PUBLIC NOTICE

In pursuance of the provision of Section 32 of the Delhi Water Board Act, 1996, it is notified for general information of the public that in the Territorial area of Delhi specified in the schedules given below, the internal sewerage system has been completed and made functional for collection, removal and disposal of all the filth, polluted and obnoxious matter from latrines, urinals and cesspools. It does not include any industrial effluent or any other discharge prohibited under law.

To encourage consumers for taking legal sewer connections, Cabinet vide Decision No.2775 dated 18.11.2019 has approved a Scheme called 'MUKHYAMANTRI MUFT SEWER CONNECTION YOJNA' under which all consumers, from areas where sewer lines have been laid/notified/made functional, who applies for a new sewer connection before 31.03.2020 shall not be charged any amount i.e. Form Charges, R.R. Charges and Installation Charges and DJB shall provide them sewer connection at its own cost.

The plot- holders / occupiers are advised to apply for sanction of sewer connection online on DJB Customer Portal www.djb.gov.in or in hard copy in the prescribed form which may be obtained from the office of Zonal Revenue Officer, c/o M/s. NWS, Q-Block, Mohan Garden, Near Jain Road, New Delhi. Applicants may contact to Toll Free No.1800-30000 Customer Care-180030000136. The form can also be down-loaded from DJB's website www.djb.gov.in. In all cases, where applications of sewer connection are received upto 31.03.2020, after sanction of sewer connection, the said sewer connection will also be laid by DJB, without any charge to the consumer.
