After sanction of water connection and payment of initial charges, the applicant shall be allowed to execute the work at his level by engaging a licensed plumber. The onus will be on the plot holders to get the bills from ZRO office of D.J.B (Zonal Revenue Officer (NW)-II, Safiabad Road Over Head Tank, Narela, Delhi-110040).
