PUBLIC NOTICE

Applications are invited from eligible persons who possess the following qualifications/eligibility for registration of new plumbers in Delhi Jal Board:

1. He/ She is a citizen of India & is at least 21 years of age, and
2. Holds:
  - a) A Diploma in Civil Engineering or an equivalent or higher qualification as approved by AICTE

Or

- b) Possess a certificate of plumbing or in Sanitary Engineering recognized by the Institution of Engineers or by the AICTE

Or

- c) Certification; duly notarized, to the effect that he has a minimum 5 years of experience under a licensed plumber (false & vague certificate will lead to revocation of license of certifying plumber) and that he has practiced plumbing under the supervision of a licensed plumber. Such persons shall be at least XII passed from a recognized Board.

Or

- d) He/ She holds a certificate in Plumbing or Sanitation from a recognized Industrial Training Institutes or a certificate of Skilled Development Programs of the States & Central Govt. like Pradhan Mantri Kaushal Vikas Yojna etc.
    - e) Retired Fitters/Assistant Fitters of Delhi Jal Board shall be eligible for applying/obtaining Plumber's License.

No interviews will be held for selection of eligible applicants for registration as plumbers in Delhi Jal Board. All applicants meeting the eligibility criteria shall be entitled for plumber's registration in Delhi Jal Board without holding any Written Examination and Interview.

**OTHER TERMS & CONDITIONS:**


1. Mere applying for the Empanelment/registration for Licensed Plumber, does not make any right for issue of license for plumber.
2. Only individual candidates may apply. No firms/partnerships/company shall be eligible.
3. Candidates meeting the eligibility criteria will only be eligible for registration in Delhi Jal Board.
4. Delhi Jal Board may grant license to any person in accordance with the provisions and may charge fees for the same at such rates as may be fixed from time to time by the Department.
5. Every license granted shall be valid for a period of 05 years up to 31<sup>st</sup> day of March applicable following the date of issue and as amended from time to time.
6. Eligible candidates shall be required to deposit Rs. 5000/- as Security Deposit and License fee of Rs. 2000/- for five years. In addition registration fee of Rs. 150/- and Plumbing License Booklet charges of Rs. 25/- subject to revision/prevailing charges, will be applicable at the time of registration. A fee of Rs.100/- for issue of Laminated Identity Card will be applicable and as amended from time to time.
7. All the photocopies of documents attached with the application must be Self Attested and both the pages of the application must be signed by the applicant.
8. Decision of the Competent Authority of Delhi Jal Board shall be final in the matter/ any dispute.
9. Applications received through DAK/ SPEED POST and after due date shall not be entertained and deemed to be rejected.
