**PUBLIC NOTICE**

Notice is hereby given in pursuance of section 9 (1) (a) of the Delhi Water Board Act, 1998 that in the area of state of Delhi as specified in the Schedule below, water is available from the water source of the Board for reasonable supply to all the lands and buildings in such area.

It is notified, that development charges for water @ Rs. 440/- Per Sq.m. of the plotted area are recoverable, subject to following terms & conditions:

- (a) **Water development charge would be recoverable at the rate Rs.100/- per sq.mtr. for properties used for residential purposes having area upto and including 200 Sq. Mtr. upto three months from the issuance of this Public Notice as per Notification No.DJB/ DOR/DD(R)HQ-II/ 2015/7379 to 7567 dated 29-06-2015, or the last date of extended period of scheme of reduced rates of development charges as per Notification No.DJB/DOR/ JD(R)HQ/2018/9869 to 10011 dated 30-10-2018 whichever is later, presently upto 31-03-2020.**
- (b) If a consumer is unable to pay the development charges as per the notified rates in lump sum or in part, then in that case simple interest @ 10% per annum will be levied on expiry of 12 months' period from the date of this notification of service in the colony.

The plot-holders / occupiers are advised to apply for sanction of water connection online on DJB Customer Portal [www.djb.gov.in](http://www.djb.gov.in) or in hard copy in the prescribed form which may be obtained from the office of **Zonal Revenue Officer (West)-III, Twin OHT, Outer Ring Road, Pashcim Vihar, New Delhi-110063..** The form can also be down-loaded from DJB's website [www.djb.gov.in](http://www.djb.gov.in). After sanction of water connection and payment of initial charges, water development charges and road restoration charges, the applicant shall be allowed to obtain boring permission and execute the work at his level by engaging a licensed plumber. The onus will be on the plot-holders to get the bills from above office of D.J.B. for development charges to be paid.
